- 2. Although all care will be taken with the digital images, the photographer limits any and or all loss or damage. Failure to deliver the digital images/photographs to the client captured from the contracted wedding photoshoot will result in that portions return of ALL deposits made to Jon Hewson Photography, to the contractual party.
- 3. Upon signature and payment of \$145 booking fee, Jon Hewson Photography reserves that time and date agreed upon and will not make any other reservations for that time and date.

For this reason, the booking fee and all deposits made are non-refundable, even if the date is changed or the wedding cancelled for any other reason.

- 4. Final payment of outstanding amount is to be paid 7 days prior to the wedding day.
- 5. If the contracting party requires photography coverage at their reception, an extra seat and meal would be greatly appreciated.
